ORDER

Decision and Order By No. 18936, filed on October 10, 2001, we approved the application of PATTI JO STRATTON, dba KONA COFFEE TOURS (Applicant), for a certificate to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Hawaii in the 1-to-7 passenger classification, limited to serving the Districts of North Kona and South Kona. We also: (1) ordered Applicant, as a condition to our approval of the application, to comply with all commission requirements for common carriers, including submitting certain documents within 120 days of the issuance of the decision and order; and (2) notified Applicant that failure to timely comply with the commission's requirements would constitute cause for the commission to void the decision and order. We served Applicant with a copy of the decision and order by mail, postage prepaid, on the same day that the decision and order was issued, in accordance with Hawaii Administrative Rules 88 6-61-21 and 6-61-122. Additionally, we sent а letter to Applicant, dated October 10, 2001, which reiterated the commission's requirements and specified February 10, 2002, as the deadline for compliance. Our letter of October 10, 2001, also stated that Applicant could request a 30-day extension to comply. On January 15, 2002, Applicant filed a request for an extension to comply, which was approved on January 16, 2002.

The extended due date for compliance of March 2, 2002, has passed, and Applicant has not complied with the requirements set forth under Decision and Order No. 18936. The commission, thus, determines that Decision and Order No. 18936 should be voided.

THE COMMISSION ORDERS that Decision and Order No. 18936 is voided and this docket is closed.
