#### ORDER

#### I.

On June 25, 2002, HAWAIIAN ELECTRIC COMPANY, INC. (HECO) filed an application requesting commission approval of the Pole Attachment Agreement between HECO and AT&T Corp., dated June 4, 2002 (Agreement). HECO attached the Agreement to its application and designated it as Exhibit 1. The request was made pursuant to Hawaii Revised Statutes 8 269 - 19and Hawaii Administrative Rules (HAR) § 6-80-78(a).

served two copies of the application on HECO the DIVISION OF CONSUMER ADVOCACY OF THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS (Consumer Advocate). On September 4, 2002, the Consumer Advocate served HECO with information requests (IRs). On September 19, 2002, HECO filed its responses to the IRs.

HAR § 6-80-78(c) requires the commission to approve or reject agreements concerning access to poles, ducts, conducts, and rights-of-way adopted voluntarily by negotiation within 90 days after submission of the agreements for commission approval (90-day review period). If the commission fails to act within the prescribed time, the agreement is deemed approved.<sup>1</sup>

The 90-day review period for the commission to act on HECO's application in this docket expires on September 23, 2002. By letter dated and filed September 20, 2002, HECO voluntarily waives the requirement that the commission approves or rejects its application within the 90-day review period (waiver), until October 23, 2002.<sup>2</sup>

### II.

Upon review, the commission will approve HECO's waiver, forth in its letter, filed on September 20, 2002. set as Based on the unique circumstances of this docket, the commission finds it reasonable expressly set date to а for the Consumer Advocate to file its statement of position. Thus, the commission concludes that it should require the Consumer Advocate to file its statement of position on the matters of this docket by October 16, 2002.

#### III.

# THE COMMISSION ORDERS:

1. HECO's waiver filed on September 20, 2002, is approved.
