DECISION AND ORDER

By Order No. 19589, filed on September 30, 2002, the commission ordered HITS HAWAII, INC., dba HOLIDAY INTERNATIONAL TRAVEL SERVICE (Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002, to show cause why Respondent's certificate of public convenience and necessity number 1681-C should not be suspended or revoked for Respondent's failure to timely pay a penalty of \$200.25, which the commission assessed pursuant to Hawaii Revised Statutes § 271-27(i) and Hawaii Administrative Rules § 6-62-42 for Respondent's late filing of the 2001 annual financial report and late payment of its annual motor carrier gross revenue fee.

On October 9, 2002, Respondent paid the assessed penalty.

Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the motor

carrier laws, rules, and regulations, and concludes that Order No. 19589 should be vacated.

THE COMMISSION ORDERS that Order No. 19589 is vacated and this docket is closed.
