DECISION AND ORDER

By Order No. 19578, filed on September 30, 2002, the commission ordered FILM FLICKS HAWAII HISTORICAL ADVENTURES, INC. (Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002 to show cause why Respondent's certificate of public convenience and necessity number 3547-C should not be suspended or revoked for Respondent's failure to timely file an annual financial report (AFR), pursuant to Hawaii Revised Statutes (HRS) § 271-25, and pay an annual motor carrier gross revenue fee (Fee), pursuant to HRS § 271-36.

On October 3, 2002, Respondent filed its 2001 AFR and paid the Fee. On October 11, 2002, Respondent paid penalties assessed pursuant to HRS § 271-27(i) and Hawaii Administrative Rules § 6-62-42.

Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 19578 should be vacated.

THE COMMISSION ORDERS that Order No. 19578 is vacated and this docket is closed.
