DECISION AND ORDER

By Order No. 19561, filed on September 30, 2002, the commission ordered J.K.P. & SONS TRUCKING, INC. (Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002 to show cause why Respondent's certificate of public convenience and necessity number 5089-C should not be suspended or revoked for failure to timely pay a penalty of \$1,000.66, which the commission assessed for Respondent's untimely annual financial report filing and annual motor carrier gross revenue fee payment, pursuant to HRS § 271-27(h) and Hawaii Administrative Rules § 6-62-42.

On October 15, 2002, Respondent paid the penalty assessed by the commission.

Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the

motor carrier laws, rules, and regulations, and concludes that Order No. 19561 should be vacated.
