## DECISION AND ORDER

By Order No. 19595, filed on September 30, 2002, the commission ordered MARCO CHEN CHIU, dba CHU TRAVEL INTERNATIONAL (Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002 to show cause why Respondent's certificate of public convenience and necessity number 1303-C should not be suspended or revoked for failure to file an annual financial report (AFR), pursuant to HRS § 271-25.

On October 25, 2002, Respondent filed its 2001 AFR, and on October 28, 2002, paid the penalties assessed pursuant to HRS § 271-27(i) and Hawaii Administrative Rules § 6-62-42.

Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 19595 should be vacated.
