<u>ORDER</u>

By Decision and Order No. 19759 (Decision and Order), filed on October 31, 2002, the commission vacated an order compelling INTERCONTINENTAL COMMUNICATIONS GROUP, INC., dba FUSION TELECOM (Respondent) to appear at a hearing to show cause why its certificate of authority should not be revoked for failure to file an annual financial report. However, the Decision and Order contained a typographical error.
