DECISION AND ORDER

By Order No. 19569, filed on September 30, 2002, the commission ordered PACIFIC SERVICES, INC. (Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002 to show cause why Respondent's certificate of public convenience and necessity number 0023-C should not be suspended or revoked for failure to pay the penalty of \$2,211.65 assessed by the commission, pursuant to Hawaii Revised Statutes § 271-27(i) and Hawaii Administrative Rules § 6-62-42, for Respondent's failure to timely file an annual financial report and pay an annual motor carrier gross revenue fee. On November 14, 2002, Respondent paid the penalty imposed by the commission.

Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the

motor carrier laws, rules, and regulations, and concludes that Order No. 19569 should be vacated.
