(Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002 to show cause why Respondent's certificate of public convenience and necessity should not be suspended or revoked for failure to file an annual financial report (AFR), pursuant to HAR § 6-80-91, and pay a public utility fee (Fee) that was due on July 31, 2001 and December 31, 2001, pursuant to Hawaii Revised Statutes § 269-30.

On October 28, 2002, Respondent filed its 2000 AFR and paid the Fees that were due on July 31, 2001 and December 31, 2001.

Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the applicable laws, rules, and regulations, and concludes that Order No. 19629 should be vacated.
