#### ORDER

I.

On August 15, 2002, TRANS MARINE, LLC (Applicant) filed an application for a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 passenger classification.

By Decision and Order No. 19742, filed on October 29, 2002, in this docket, the Commission granted Applicant's request for motor vehicle authority as a common carrier, 1-to-7 passenger classification, over irregular routes, on the island of Oahu.

On November 19, 2002, Applicant filed a request to withdraw its application as it intended to apply 8-to-25 passenger classification instead of the 1-to-7 passenger classification. The commission finds good cause to grant Applicant's request, and to void Decision and Order No. 19742.
