## DECISION AND ORDER

By Order No. 19594, filed on September 30, 2002, the commission ordered KYUNG HO HYUN, dba MICKEY LIMOUSINE & TOUR (Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002 to show cause why Respondent's certificate of public convenience and necessity (CPCN) number 1614-C should not be suspended or revoked for failure to pay a penalty of \$200.62 assessed by the commission, pursuant to Hawaii Revised Statutes § 271-27(i) and Hawaii Administrative Rules § 6-62-42, for Respondent's untimely annual financial report filing and annual motor carrier gross revenue fee payment. The commission notified Respondent that

its CPCN would be revoked if it failed to appear at the scheduled hearing.

On October 29, 2002, Respondent failed to appear before the commission's hearings officer. As a result, the hearings officer recommended that: (1) Respondent be found in default for failure to appear at the hearing, and (2) Respondent's CPCN be revoked.

the above, the commission Based on finds that Respondent has not complied with Order No. 19594, the applicable laws, rules, and regulations, and concludes that Respondent's CPCN should be revoked.

THE COMMISSION ORDERS that CPCN No. 1614-C is revoked.
