ORDER

I.

By Decision and Order No. 19908, filed on December 17, 2002, the commission revoked the certificate of authority (COA) held by PT-1 COMMUNICATIONS, INC. (Movant), for failure to pay a public utility fee (Fee) that was due on July 31, 2001, pursuant to Hawaii Revised Statutes § 269-30.

On December 23, 2002, Movant paid the Fee and filed a statement detailing the computation of the Fee due to the commission on July 31, 2001. The commission will treat Movant's statement as a motion for reconsideration of Decision and Order No. 19908.¹

Based on the above, the commission finds that Movant has fully complied, although belatedly, with the applicable laws, rules, and regulations of the State of Hawaii, and concludes that
