Decision and Order No. 20000

DECISION AND ORDER

I.

By an application filed on August 29, 2002, Applicant DAVID PAUL HARTZ, dba ALOHA WATER DELIVERY¹ (Applicant), requests that the commission impose a moratorium on the issuance of new certificates of public convenience and necessity for common carriers of property in the specific commodities classification (water hauling) in the areas of Kau, North Kona, and South Kona on the island of Hawaii (hereinafter, proposed moratorium).

Applicant served copies of the application on the DIVISION OF CONSUMER ADVOCACY, DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS (Consumer Advocate). On September 13, 2002, the

Consumer Advocate informed the commission that it will not be participating in this docket.

II.

Upon our review and consideration of the record, the commission finds that Applicant has failed to satisfy its burden in demonstrating the merits of the proposed moratorium, at this Specifically, we are aware of the approximately juncture. 47 carriers authorized to transport general commodities (including water hauling) on the island of Hawaii and the approximately 15 carriers authorized to transport specific commodities (water hauling) on the island of Hawaii.² However, the record is devoid of any relevant and credible evidence (i.e., charts, data and studies indicating, among other things, a declining trend in total gross revenues of these carriers and that these carriers are approaching a level that the market cannot reasonably and efficiently sustain)³ in the common carrier industry, particularly with respect to these property carriers of general commodities and specific commodities (water haulers). Specifically, we are not convinced that the suspension of our laws, rules, and procedures governing entry regulation of the above-mentioned property carriers will foster sound economic conditions consistent with the intent and policy of the carrier motor laws,

Hawaii Revised Statutes chapter 271. Accordingly, we conclude that Applicant's application for the proposed moratorium should be denied, without prejudice.

III.

THE COMMISSION ORDERS that Applicant's application, filed on August 29, 2002, requesting the commission to impose a moratorium on the issuance of new certificates of public convenience and necessity for common carriers of property in the specific commodities classification (water hauling) in the areas of Kau, North Kona, and South Kona on the island of Hawaii, is denied, without prejudice.
