(Applicant), seeks commission MOLOKAI approval of a rate increase and revised rate schedule pursuant to Hawaii Revised Statutes (HRS) § 269-16. Applicant is a public utility authorized to provide water service to an area covering approximately 6,800 acres on the west end of the island of Molokai.

By Order No. 19955, filed on January 14, 2003, commission. among other things, ordered Applicant and Division of Consumer Advocacy, Department of Commerce and Consumer Affairs (Consumer Advocate), to submit a stipulated prehearing order to the commission within 20 days from the date of Order No. 19955.

By letter filed with the commission on February 3, 2003, Applicant advised the commission that it is still in the process, with the Consumer Advocate, of finalizing the issues, procedures and schedule to be included in the stipulated prehearing order, and that Applicant requests an extension of time, until February 7, 2003, to file the stipulated prehearing order.
