ORDER

I.

By letter filed on January 13, 2003, LUCIA ELMALEH, dba UNIQUE ADVENTURES (Petitioner), requests that certificate of public convenience and necessity no. 1734-C (Certificate No. 1734-C) be placed on inactive status. Certificate No. 1734-C authorizes Petitioner to transport passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification.




II.


