opposed to \$37.83 per month. As recognized by PWI, the commission-approved minimum charge is \$37.83 per month.¹ The minimum charge set forth in Section 2.2 is clearly an error. Thus, PWI should amend Section 2.2 to reflect the minimum charge approved by the commission in Order No. 19980 and as set forth in PWI's revised rate schedule. In all other respects, PWI's compliance filing, filed on February 10, 2003, appears to be in compliance with Order No. 19980.

Accordingly, PWI's compliance tariff filing is approved provided that PWI re-files its rules and regulations with an amended Section 2.2 in accordance with this order.




