<u>ORDER</u>

I.

By an application filed on October 24, 2002, GLOBAL ACCESS TELECOM & VOIP CORPORATION (Applicant) requests that the commission grant it a certificate of authority to operate as a reseller of intrastate telecommunications services in the State of Hawaii. Applicant makes its request pursuant to Hawaii Revised Statutes § 269-7.5 and Hawaii Administrative Rules (HAR) § 6-61-74.

By notice of dismissal dated February 27, 2003,¹ the commission informed applicant of its intention to dismiss the application in this docket without prejudice due to Applicant's failure to comply with commission rules and respond to our requests. Further Applicant was advised that any objection to
