ORDER

I.

By Order Nos. 18122, 19088, and 19819, filed on October 4, 2000, November 29, 2001, and November 26, 2002, respectively, certificate of public convenience and necessity no. 4825-C (Certificate No. 4825-C), held by JUNE A. NOZOE, dba ISLAND EXCLUSIVE (Petitioner), was placed on inactive status for a cumulative period of two years, ending February 27, 2003. The commission notes that under Hawaii Revised Statutes (HRS) § 271-19, the commission may grant inactive status for a cumulative period not to exceed two years over the life of the certificate.

By letter filed on March 6, 2003, Petitioner requests commission approval to voluntarily surrender her authority under Certificate No. 4825-C. Under Certificate No. 4825-C, Petitioner is authorized to transport passengers by motor vehicle over irregular routes on the island of Maui in the 1-to-7 passenger classification.

In accordance with Hawaii Revised Statutes (HRS) § 271-19, operating authority under a certificate of public convenience and necessity may be terminated upon application of the holder. The commission finds good cause to grant Petitioner's request to terminate her authority.

II.

THE COMMISSION ORDERS:

1. Petitioner's authority to transport passengers under Certificate No. 4825-C is terminated, effective from the date of this order.


2. Petitioner shall surrender her certificate and remove any markings from the vehicles used in her operations. Petitioner shall comply with the foregoing requirements within 30 days from the date of this order.


3. If Petitioner fails to comply with the foregoing requirements within the time period specified, she may be subject to penalties pursuant to HRS § 271-27.


