ORDER

I.

By transmittal number 2003-01, filed on March 14, 2003, E NOA CORPORATION (E Noa) seeks commission approval on short notice of certain changes to its tariff. E Noa makes its request in accordance with Hawaii Revised Statutes § 271-21 and Hawaii Administrative Rules § 6-63-18. The proposed effective date of E Noa's transmittal is April 1, 2003.

E Noa seeks to add a trolley shuttle service from the Honolulu International Airport to certain Waikiki hotels and Duty Free Shoppers Waikiki, aka DFS Galleria, with service dependent upon the airlines' arrival and departure schedules.¹ E Noa proposes a charge of \$8.50 per passenger, round trip, plus \$2.00 per baggage.

E Noa states that: (1) a major Japanese travel agency requests this shuttle service for its clients; (2) the agreement to provide this service "has just recently been finalized[;]" and

(3) the travel agency seeks to commence this service on April 1, 2003. For these reasons, E Noa seeks approval of transmittal number 2003-01 on short notice.

Upon review, the commission finds good cause to approve E Noa's request on short notice, effective from April 1, 2003.




