ORDER

The commission takes official notice, pursuant to Hawaii Administrative Rules § 6-61-48, of an obituary printed in the February 26, 2003 edition of *The Honolulu Advertiser* which informed the commission that WILLIAM K. BUCHANAN, JR. passed away on February 20, 2003.¹ Mr. William K. Buchanan, Jr., dba Molokai Security Service, was authorized under Permit No. 4614-P to operate as a contract carrier of property by motor vehicle on the island of Molokai to transport specific commodities including (1) mail, cash and checks, pursuant to a contract with the Hawaii State Department of Education, (2) bank deposits and bank bags, pursuant to a contract with the County of Maui, and (3) money, bank deposits, empty containers, receipts, mail, and documents, pursuant to contracts with Molokai Ranch, Ltd., Budget Rent A Car Systems, Inc., and Molokai Community Federal Credit Union.


As Mr. Buchanan passed away on February 20, 2003, the commission finds good cause to terminate Permit No. 4614-P as of the date of Mr. Buchanan's death.


¹The passing of Mr. Buchanan was also confirmed in writing by commission staff by letter dated March 7, 2003 to Mr. Buchanan's son.


