#### ORDER

I.

By Rate Notice No. 4345-8-C, filed on March 24, 2003, WESTERN MOTOR TARIFF BUREAU, INC. (WMTB). on behalf of ROBERT'S TOURS INC., seeks AND TRANSPORTATION, commission approval on short notice of certain changes to its tariff. For the island of Oahu, Robert's Tours and Transportation, Inc. is duly authorized to operate regular route service in the over-25 passenger classification, within the geographic area from Waikiki to Waikele Center.<sup>1</sup>

WMTB makes its request in accordance with Hawaii Revised Statutes § 271-21 and Hawaii Administrative Rules § 6-63-18. The proposed effective date of WMTB's rate notice is April 1, 2003.

Hilo Hattie and the Aloha Tower Marketplace seek to increase visitor traffic by initiating a chartered, regular route

service from certain Waikiki hotels to their respective destinations, and back to Waikiki, continuously, from 8:20 a.m. to 6:05 p.m., each day. Robert's Tours and Transportation, Inc. has been hired to provide this chartered service.

Upon review, the commission finds good cause to grant WMTB's request for approval on short notice. WMTB shall promptly file its revised tariff sheet, incorporating the correct effective date.<sup>2</sup>

#### II.

## THE COMMISSION ORDERS:

1. WMTB's Rate Notice No. 4345-8-C, filed on March 24, 2003, is approved on short notice, to be effective from April 1, 2003.

2. WMTB shall promptly file its revised tariff sheet, consistent with the terms of this order.
