ORDER

I.

By transmittal filed on April 9, 2003, TRI ISLE, INCORPORATED, dba VALLEY ISLE EXPRESS, and dba HALEAKALA TRANSPORTATION & WAREHOUSE (Tri Isle, Inc.), seeks commission approval on short notice to increase its fuel surcharge, as follows:

1. General commodities and break bulk and delivery: from .43 to .70 per cent.
2. Dump truck: from .68 to 1.18 per cent.

In support of its increase, Tri Isle, Inc. attaches a copy of a recent invoice from its fuel supplier, which shows that the per gallon rates for diesel fuel and gasoline increased by .07 cents and .12 cents, respectively.¹

¹Tri Isle, Inc.'s general commodities and break bulk and delivery vehicles utilize diesel fuel and gasoline, while its dump trucks utilize diesel fuel.

Tri Isle, Inc. makes its request in accordance with Hawaii Revised Statutes § 271-21 and Hawaii Administrative Rules § 6-63-18. It proposes an effective date of April 15, 2003.

Upon review, the commission finds good cause to grant Tri Isle, Inc.'s request for approval on short notice.


II.
