ORDER

I.

By Decision and Order No. 16792, filed on January 14, 1999, the commission granted TELEGLOBE USA INC. a certificate of authority (COA) to operate as a reseller of intrastate telecommunications services. Teleglobe USA Inc. was issued COA 99-0001 by the commission.

Recently, by Decision and Order No. 20116, filed on April 8, 2003, in Docket No. 03-0020, the commission waived its review of a reorganization involving the sale and transfer of Teleglobe USA Inc.'s assets. In addition, the commission: (1) granted a COA to Teleglobe USA Inc.'s successor-in-interest, Teleglobe USA LLC; and (2) stated its intent to approve the voluntary surrender of Teleglobe USA Inc.'s COA.<sup>1</sup> The commission

By separate order, in Docket No. 99-0001, the commission will approve the voluntary surrender of Teleglobe USA Inc.'s COA. In this respect, in response to the commission's directive, Teleglobe USA Inc., on April 3 and 4, 2003, submitted its: (1) annual financial reports for the years 2002 and 2003; and (2) public utility fee payments.

also noted that Teleglobe USA Inc.: (1) does not have any Hawaii-based customers; and (2) currently does not provide intrastate service in Hawaii.<sup>2</sup>

Upon review, the commission finds good cause to approve the proposed surrender of Teleglobe USA Inc.'s COA, consistent with Decision and Order No. 20116. In addition, under the circumstances, the commission will waive as inapplicable the customer notification requirement set forth in Hawaii Administrative Rules § 6-80-123.

## II.

### THE COMMISSION ORDERS:


1. Teleglobe USA Inc.'s request to surrender its COA to operate as a reseller of intrastate telecommunications services is granted, effective from the date of this order. Teleglobe USA Inc. shall promptly return COA 99-0001 to the commission.
2. This docket is closed.




