ORDER

I.

By Decision and Order No. 18575, filed on June 1, 2001, the commission approved the standby service rider (aka Rider A) agreed upon between HAWAII ELECTRIC LIGHT COMPANY, INC. (HELCO) and the Division of Consumer Advocacy (Consumer Advocate), subject to certain reporting requirements. Specifically, at page 8 of its decision and order, the commission stated:

Accordingly, HELCO shall, by July 31, 2002, submit to the commission and Consumer Advocate a report detailing, at a minimum: (1) the number of customers on Rider A and the terms and form of each customer's standby service; (2) the number of customers that have opted to leave HELCO's system in toto in lieu of standby service; (3) the amount of kWh reduction due to customers leaving HELCO's system or who opt for standby service; (4) the corresponding amount of revenue loss due to the reduction in kWh sales and demand consumption; (5) the impact to HELCO's rate of return as a result of this revenue loss; (6) each standby customer's peak load and generating capacity installed; and (7) how the customer is base loading its own generating units.

This report, the commission envisions, will provide the historical data and information needed to evaluate the impact to HELCO's revenue requirement resulting from customers who choose to leave the utility system either partially or

in toto. Any adjustments to the rider, if necessary, can then be made.

On August 7, 2002, HELCO submitted its standby service report, in compliance with Decision and Order No. 18575 and Order No. 19493. On December 26, 2002, a response by Hess Microgen, LLC to HELCO's standby service report was submitted to the commission.

II.

Upon review, the commission finds it prudent and consistent with the public interest for HELCO to file additional, annual status reports on its standby service rider. Furthermore, in addition to the information and data set forth at page 8 of Decision and Order No. 18575, the commission will revise the scope of paragraph (4), governing HELCO's loss revenues, on a going-forward basis. Specifically, the commission will require that the corresponding amount of revenue loss due to the reduction in kWh sales and demand consumption be broken down by its various components. This should enable the commission and Consumer Advocate to better determine whether HELCO's Rider A is a deterrent for cogeneration and other non-utility generation.
