DECISION AND ORDER

I.

By Order No. 19962 (Order No. 19962), filed on January 14, 2003, the commission granted SUNTREK TOURS, INC.'S (Respondent's) motions for reconsideration of and to (Order No. 19891 Decision and Order No. 19891), filed on December 17, 2002, which revoked Respondent's certificate of public convenience and necessity number 1592-C. Order No. 19962 Respondent's motions subject following granted to the conditions: (1) Respondent must file an annual financial report (AFR) that complies with Hawaii Revised Statutes (HRS) § 271-25 within 30 days of Order No. 19962 and (2) Respondent must pay the annual motor carrier fee (Fee) and any delinquent filing penalties and interest assessed by the commission pursuant to HRS § 271-27(h) and (i) and Hawaii Administrative Rules (HAR) § 6-62-42 within 30 days of Order No. 19962.

On January 31, 2003, Respondent filed its 2001 AFR and on February 21, 2003 paid its Fee and the penalties and interest assessed pursuant to HRS § 271-27(i) and HAR § 6-62-24 and -42.

Based on the above, the commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 19607, filed on September 30, 2002, and Order No. 19891, filed on December 17, 2002, should be vacated.

II.

THE COMMISSION ORDERS that Order No. 19607, filed on September 30, 2002, and Order No. 19891, filed on December 17, 2002, are vacated and this docket is closed.
