<u>ORDER</u>

I.

By Decision and Order No. 16863, filed on February 23, 1999, the commission granted CENTURYTEL LONG DISTANCE, INC. ("Petitioner") a certificate of authority ("COA") to operate as a reseller of intrastate telecommunications services. Petitioner was issued COA 99-0016 by the commission.

By letter dated June 4, 2003, filed on June 5, 2003, Petitioner seeks commission approval to voluntarily surrender its COA. Petitioner states that it "does not have any customers in Hawaii and has ceased offering telecommunications services in the [S]tate." Thereafter, Petitioner submitted its applicable public utility reports and fees, in response to the commission's directive.

Upon review, the commission will: (1)approve the voluntary surrender of Petitioner's COA; and (2) waive the notification requirement forth in customer set Hawaii Administrative Rules § 6-80-123(a), as Petitioner represents that it does not have any intrastate customers to notify of its proposed discontinuance of telecommunications services.

II.

THE COMMISSION ORDERS:

1. Petitioner's request to surrender COA 99-0016 to operate as a reseller of intrastate telecommunications services is approved, effective from the date of this order. Petitioner shall promptly return COA 99-0016 to the commission.

2. This docket is closed.
