ORDER

I.

By transmittal filed on July 3, 2003, LAUNIUPOKO WATER COMPANY, LLC ("Applicant") submitted its updated tariff, which incorporates the amended tariff sheets and rate schedules, requested by Decision and Order No. 20274 ("Decision and Order No. 20274"), filed on June 27, 2003, in this docket. On July 15, 2003, the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy ("Consumer Advocate") wrote to the commission, stating that it reviewed Applicant's revised tariff and found that Applicant addressed the concerns of the Consumer Advocate. Upon a review of the revised tariff, the commission finds that Applicant's transmittal complies with the terms and conditions of Decision and Order No. 20274. Thus, the commission concludes that Applicant's revised tariff sheets and rate schedules should be allowed to take effect on July 18, 2003.




THE COMMISSION ORDERS:


1. Applicant's revised tariff sheets and rate schedules will be allowed to take effect on July 18, 2003.


