ORDER

I.

By Decision and Order No. 19873, filed on December 12, 2002, the commission granted TRI-K INVESTMENTS, LLC, dba HT&T HAULING & REPAIR ("Transferee"), temporary authority to operate the motor carrier properties of BREWER ENVIRONMENTAL INDUSTRIES, INC., dba HT&T COMPANY ("Transferor"), under Transferor's certificate of public convenience and necessity no. 5016-C ("Certificate No. 5016-C"). The temporary transfer of authority allowed Transferee to operate as a common carrier of property over irregular routes on the island of Hawaii in the general commodities and dump truck classifications. The temporary authority was valid for 120 days from the date of the Decision and Order, or until April 12, 2003.

Subsequently, by Decision and Order No. 19957, filed on January 14, 2003, in consolidated Docket Nos. 02-0376 and 02-0387, the commission granted Transferee permanent authority to operate the motor carrier properties of Transferor under Transferor's


Certificate No. 5016-C. As the authority applied for on a temporary basis in this docket is the same authority granted to Transferee on a permanent basis by Order No. 19957, the filing of Order No. 19957 has rendered this docket moot. We, thus, conclude that there is good cause to close the instant docket.


II.


THE COMMISSION ORDERS that this docket is closed.


