ORDER

By Decision and Order No. 19834, filed on December 2, 2002, we approved the application of DARREN R. CARVALHO, dba DARREN'S TOWING & TRUCKING ("Applicant"), for a certificate to operate as a common carrier of property by motor vehicle over irregular routes on the island of Hawaii in the general commodities and dump truck classifications. We also: (1) ordered Applicant, as a condition to our approval of the application, to comply with all commission requirements for common carriers, including submitting certain documents within 120 days of the issuance of the decision and order; and (2) notified Applicant that failure to timely comply with the commission's requirements would constitute cause for the commission to void the decision and order. We served Applicant with a copy of the decision and order by mail, postage prepaid, on the same day that the decision and order was issued, in accordance with Hawaii Administrative Rules 88 6-61-21 and 6-61-122. Additionally, we sent a letter to Applicant, dated December 2, 2002, which reiterated the commission's requirements and specified April 2, 2003, as the deadline for compliance.

On March 31, 2003, May 6, 2003, and May 28, 2003, Applicant filed 30-day extensions to comply. The commission approved the requests, with the third extension request being approved as a final extension, until June 28, 2003.

The final extended due date has passed, and Applicant has not complied with the requirements set forth under Decision and Order No. 19834. The commission, thus, determines that Decision and Order No. 19834 should be voided.

THE COMMISSION ORDERS that Decision and Order No. 19834 is voided and this docket is closed.
