ORDER

I.

application filed October 2002. By on 4. ELECTRIC COMPANY, LIMITED ("MECO") requests commission MAUI Substation Supply Contract approval of the Hana 41 Off-Highway No. 2 Diesel Fuel ("Fuel Supply Contract"), dated August 9, 2002, with Maui Oil Company, Inc. ("Maui Oil"). Pursuant to the Fuel Supply Contract, MECO purchases and receives from Maui Oil its entire No. 2 Diesel Fuel ("Fuel") requirements for its standby generating units located two its Hana Substation No. 41. MECO also requests commission approval to include the cost of Fuel and related taxes in MECO's Energy Cost Adjustment Clause ("ECAC") to the extent that the costs are not recovered in MECO's base rates.

MECO served copies of its application on the Division of Consumer Advocacy, Department of Commerce and Consumer Affairs ("Consumer Advocate").

On October 17, 2002, the Consumer Advocate filed its Preliminary Statement of Position indicating that MECO did not

provide sufficient information to support the requested approval and that it would participate in this proceeding and issue information requests. On October 17, 2002, the Consumer Advocate served MECO with its First Submission of Information Requests upon MECO. On November 4, 2002, MECO filed its responses to the Consumer Advocate's First Submission of Information Requests. On March 6, 2003, the Consumer Advocate filed its Statement of Position indicating that it does not object to the commission approving the Fuel Supply Contract. However, it does object to the inclusion of such costs in MECO's ECAC. On May 27, 2003, MECO filed a letter requesting an evidentiary hearing on the matter.

In light of MECO's May 27, 2003 request for an evidentiary hearing and since the Consumer Advocate has not withdrawn its objection, the commission finds that establishing a procedural schedule at this juncture would aid in the efficient and timely disposition of the instant proceeding. Thus, the commission concludes that MECO and the Consumer Advocate should meet to formulate the issues, procedures and schedule with respect to this proceeding, to be set forth in a stipulated prehearing order that shall be submitted for commission approval by September 5, 2003.² In the alternative, if the parties are unable to stipulate to such order, we conclude that each party

shall submit a proposed prehearing order for the commission's consideration by September 5, 2003.

II.

THE COMMISSION ORDERS that MECO and the Consumer Advocate shall meet informally to formulate the issues, procedures, and schedule with respect to this proceeding, to be set forth in a stipulated prehearing order. This stipulated prehearing order shall be submitted for commission approval by September 5, 2003. If unable to stipulate to such an order, each party shall submit its own proposed prehearing order for the commission's consideration by September 5, 2003.
