DECISION AND ORDER

I.

By Decision and Order No. 20228, filed on June 10, 2003, the commission: (1) approved HAWAIIAN ELECTRIC COMPANY, INC.'s ("HECO") request to transfer (i.e., donate) approximately 101 retired personal computers and two hubs to four non-profit organizations; and (2) deferred HECO's other requests to a follow-up decision and order, upon the filing of a position statement by the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy ("Consumer Advocate"). Thereafter, filed 30, by position statement on July 2003, Consumer Advocate does not object to the commission's approval of HECO's remaining requests.

This decision and order addresses HECO's two pending requests.

II.

A.

Condition No. 13 (fka Condition No. 14), set forth in Decision and Order No. 7153, filed on July 19, 1982, in Docket No. 4337, provides:

The Utility Corporation shall not transfer any of its property which is or was in the rate base nor assume any liabilities of Industries, directly or indirectly, without the prior approval of the Commission. The determination of the transfer value and the accounting and rate-making treatment thereof shall be determined by the Commission at the time of approval of such transfer.²

В.

With respect to the transfer value and accounting and ratemaking treatment of the donated equipment, HECO explains that:

- 1. The original cost of the donated equipment is approximately \$366,697, and its net book value is approximately \$191,844. (Exhibit A of HECO's application.)
- 2. The accounting entries for the retired, donated equipment, based on the equipment's original cost, are: (A) a debit to Account 108.11, accumulated depreciation; and (B) a credit to Account 391.10, information system equipment.
- 3. The ratemaking treatment of the donated equipment is similar to its accounting treatment. No gain or loss is recognized.

4. The donated equipment is not recognized as a charitable contribution for accounting, ratemaking, or tax purposes.

Based on these representations, the Consumer Advocate concludes that, "although the donated equipment may have a net book value, there is no transfer value under HECO's proposal." Thus, the Consumer Advocate "does not object to the proposed accounting and rate-making treatment for the net book value of the donated equipment."

C.

HECO requests, on a going-forward basis, to file an annual report in lieu of seeking the commission's prior approval to donate retired personal computers and related equipment to non-profit organizations. Specifically, HECO proposes an annual report, on a form similar to Exhibit A of its application, for the twelve-month period ending each October 31, "submitted on or before December 1 of the same year." HECO states that the annual report "will facilitate the transfer of retired PCs and peripherals to non-profit organizations, and ensure timely receipt of the donated retired PCs and peripherals by the non-profit organizations."

The Consumer Advocate supports HECO's annual reporting proposal, stating that "[t]he report should allow the Commission and Consumer Advocate to monitor the costs impacts of the donated [equipment]."

Upon review, the commission will approve HECO's proposed: (1) accounting and ratemaking treatment for the net book value of the retired, donated equipment; and (2) annual reporting requirement in lieu of prior commission approval.

III.

THE COMMISSION ORDERS:

- 1. HECO's proposed accounting and ratemaking treatment for the net book value of the retired, donated equipment is approved, consistent with Condition No. 13 of Decision and Order No. 7153, filed on July 19, 1982, in Docket No. 4337.
- 2. In lieu of seeking the commission's prior approval to donate retired personal computers and related equipment to non-profit organizations, HECO shall, on a going-forward basis and consistent with the terms of this decision and order, file an annual informational report covering the twelve-month period from November 1 to October 31, by December 1st of the same year. The initial report is due by December 31, 2003. HECO shall serve two copies of each report on the Consumer Advocate. To the extent this new requirement conflicts with Condition No. 13 of Decision and Order No. 7153, the annual reporting requirement supersedes Condition No. 13.
