ORDER

I.

By letter dated July 29, 2003, AMERITECH WIRELESS HOLDINGS, INC. ("Petitioner") requests commission approval to voluntarily surrender its certificate of registration ("COR") to operate as a "facilities-based provider of cellular telecommunications services in the Kauai Rural Service Area."1 Petitioner explains that with the recent transfer of successor's operating assets to AT&T Wireless Services of Hawaii, Inc., it no longer operates in the State of Hawaii.² September 2, 2003, Petitioner submitted its applicable annual financial reports and public utility fees, in response to the commission's directive.

Upon review, the commission will approve the surrender of Pétitioner's COR.
