I.

On September 17, 2003,<sup>1</sup> LAUNIUPOKO WATER COMPANY, LLC ("Applicant") submitted its updated tariff, which incorporates the amended tariff sheets and rate schedules, requested by the commission in Decision and Order No. 20424 ("Decision and Order No. 20424"), filed on September 10, 2003, in this docket. On September 26, 2003, the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy ("Consumer Advocate") wrote to the commission, stating that it reviewed Applicant's revised tariff and found that Applicant addressed the concerns of the commission and the Consumer Advocate. The commission finds that Applicant's transmittal complies with the terms and conditions of Decision and Order No. 20424. Thus, the commission concludes that Applicant's revised tariff

sheets and rate schedules should be allowed to take effect on October 6, 2003.

THE COMMISSION ORDERS:

1. Applicant's revised tariff sheets and rate schedules will be allowed to take effect on October 6, 2003. Applicant shall file a copy of the revised tariff sheets and rate schedules, which reflect said effective date with the commission and the Consumer Advocate within 15 days of this decision and order.

2. This docket is closed.


