ORDER

I.

Voluntary Surrender Request

NXLD COMPANY ("Petitioner") holds a certificate of authority ("COA") to operate as a reseller of intrastate telecommunications services. Petitioner was issued COA-0129 by the commission.

Petitioner requests the commission's approval to voluntarily surrender its COA.² Petitioner states:

NXLD does not have any customers in the state of Hawaii. Particularly in light of this fact, the public will not be harmed by NXLD's surrender of its certificate and withdrawal of its applicable tariffs.

Petitioner recently submitted its applicable public utility reports and fees, in response to the commission's directive.

THE COMMISSION ORDERS:

- 1. Petitioner's request to surrender COA-0129 to operate as a reseller of intrastate telecommunications services is approved, effective from the date of this order. Petitioner shall promptly return COA-0129 to the commission.
- 2. The customer notification requirement set forth in HAR \S 6-80-123(a) is waived.
 - 3. This docket is closed.
