ORDER

I.

Tariff Filing

The commission approved VERIZON HAWAII INC.'S ("Verizon Hawaii") Local Package Plus ("LPP") service offering on a one-year promotional basis by Decision and Order No. 20195, filed on May 27, 2003. Verizon Hawaii filed initial tariff sheets consistent with the commission's directive in Decision and Order No. 20195 with an issued date of December 6, 2002, and an effective date of May 27, 2003, on June 6, 2003. Verizon Hawaii also informed the commission that it intended to file revised tariff sheets to reflect the offering's implementation date as its effective date sometime in the future since it required additional time to actually implement LPP and seeked to "roll out" LPP with another package offering, Local Package Basic ("LPB"), to minimize implementation costs.

Verizon Hawaii filed revised LPP tariff sheets to "supersede" the tariff sheets filed on June 6, 2003, on August 18, 2003. Verizon Hawaii's revised LPP tariff sheets reflected an issued date of August 18, 2003, and an effective date of August 29, 2003, and expressly stated that the offering will be provided on a promotional basis for twelve (12) months from August 29, 2003, through August 29, 2004 ("Revised Tariff").

Upon review, it appears that Verizon Hawaii's Revised Tariff is not in violation of Decision and Order No. 20195. The amendment to the effective date of Verizon Hawaii's LPP offering to reflect its implementation date, in this instance, is reasonable. Accordingly, we conclude that the Revised Tariff should be approved.

II.

Additional Reporting Requirement

The commission is currently concerned with the Inter-island Toll minutes of use ("MOU") for LPP. The Inter-island Toll service component of LPP is currently provided on an unlimited basis. The commission's concerns with this issue in this docket were expressly stated in Decision and Order No. 20195, which mirrored similar concerns with Verizon Hawaii's Local and Toll Package, a matter of Docket No. 01-0440. We are specifically concerned that Inter-island Toll minutes for LPP may be underestimated which could result in this service being

provided below its total service long run incremental cost, leading to cross-subsidization issues in violation of Hawaii Revised Statutes ("HRS") § 269-39 and Hawaii Administrative Rules ("HAR") § 6-80-35. HRS § 269-39(a) and HAR § 6-80-35(a) prohibit cross-subsidization of a telecommunications carrier's competitive its noncompetitive service offerings. services by HAR § 6-80-35(b) clarifies that cross-subsidization "is deemed to have occurred if: (1) [a]ny fully competitive or partially competitive service is priced below the total service long run providing the service; incremental cost of (2) [f]ully competitive services, taken as a whole, fail to cover their direct and allocated joint and common costs; or (3) [i]f fully competitive and partially competitive services, taken as a whole, fail to cover the direct and allocated joint and common costs."

The commission required Verizon Hawaii to closely monitor Inter-island Toll usage by LPP customers and required it to file a report on aggregate Inter-island Toll MOU for LPP, on a monthly basis, no later than 30 days before the expiration of program's one-year period, in Decision and Order No. 20195. Verizon Hawaii's LPB service offering is also provided with unlimited Inter-island Toll use. The commission approved LPB subject to specific requirements, including the requirement to file monthly reports on aggregate Inter-island Toll MOU for LPB, with two copies served on the Consumer Advocate.

The commission recognizes that Inter-island Toll MOU data filed in Docket No. 03-0067 to support Verizon Hawaii's LPB application reflects the most recent usage information on this service. Our review and re-evaluation of those Inter-island Toll

MOU figures have increased our concerns regarding Inter-island Toll usage for LPP since they indicate higher and growing MOU for Inter-island Toll service as the months progress. We believe that a stricter reporting requirement on Inter-island Toll MOU for LPP is now warranted. We find it appropriate, reasonable, and in the public interest at this juncture to adopt the same monthly Inter-island Toll MOU reporting requirement imposed on 03-0067 for LPP. in Docket No. In addition to the requirements set forth in Decision and Order No. Verizon Hawaii must also file monthly reports on aggregate Inter-island Toll MOU for LPP, with two copies served on the Consumer Advocate. Each monthly report, beginning October 2003, shall be filed within 15 days after the end of each month. The report must detail for each month: (a) the total MOU for all LPP customers; (b) the number of LPP customers; and (c) the average monthly MOU for each LPP customer.

Based on the above, we conclude that Decision and Order No. 20195 should be amended to incorporate the commission's decision to require Verizon Hawaii to file monthly reports on Inter-island Toll MOU for LPP.

III.

<u>Orders</u>

THE COMMISSION ORDERS:

- 1. Verizon Hawaii's LPP Revised Tariff is approved, after the fact.
- 2. Decision and Order No. 20195 is amended to reflect the commission's decision regarding monthly reports on 02-0415

Inter-island Toll MOU for LPP, as detailed in section II of this Decision and Order No. 20195 remains unaffected in all other respects.
