DECISION AND ORDER

The commission ordered SHANE E. K. HOPEAU, dba E Z TRUCKING ("Respondent") to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 26, 2003 to show cause why Respondent's certificate of public convenience and necessity number 2109-C should not be suspended or revoked for failure to pay \$1,798.87 of penalties and interest assessed by the commission.


On October 30, 2003, Respondent paid the penalties and interest that the commission assessed pursuant to Hawaii Revised Statutes § 271-27(i) and Hawaii Administrative Rules §§ 6-62-24(b), 6-62-24(c), and 6-62-42(d) for Respondent's untimely annual financial report filing and public utility fee payment.


The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 20486, filed on October 27, 2003, should be vacated.


THE COMMISSION ORDERS that Order No. 20486 is vacated and this docket is closed.




