#### <u>ORDER</u>

I.

### Request to Surrender Common Carrier Authority

On October 27, 2003, ROY NGUYEN ("Petitioner") filed a letter requesting commission approval to voluntarily surrender his authority under certificate of public convenience and necessity number 1772-C ("Certificate No. 1772-C"). Under Certificate No. 1772-C, Petitioner is authorized to transport passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 passenger classification. As part of his request, Petitioner returned Certificate No. 1772-C to the commission.

In accordance with Hawaii Revised Statutes ("HRS") § 271-19, operating authority under a certificate of public convenience and necessity may be terminated upon application of the holder. The commission finds good cause to grant Petitioner's request to terminate his authority.

II.

#### <u>Orders</u>

#### THE COMMISSION ORDERS:

- 1. Petitioner's authority to transport passengers under Certificate No. 1772-C is terminated, effective from the date of this order.
- 2. Petitioner shall remove any markings from the vehicles used in his operations. Petitioner shall comply with the foregoing requirement within 15 days from the date of this order.
- 3. If Petitioner fails to comply with the foregoing requirement within the time period specified, he may be subject to penalties pursuant to HRS § 271-27.
  - 4. This docket is closed.
