DECISION AND ORDER

The commission ordered JERALD L. KRINGEL, dba CONTRACTOR'S DUST-BUSTERS ("Respondent") to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 26, 2003 to show cause why Respondent's certificate of public convenience and necessity number 2076-C should not be suspended or revoked for failure to pay an annual motor carrier gross revenue fee ("Fee"), pursuant to Hawaii Revised Statutes ("HRS") § 271-36 and Hawaii Administrative Rules ("HAR") § 6-62-24(a), for 2002.

On November 7, 2003, Respondent paid his Fee, and on November 13, 2003, paid \$521.58 for penalties and interest that the commission assessed, pursuant to HRS § 271-27(i) and HAR §§ 6-62-24(b) and 6-62-24(c).

The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules,


and regulations, and concludes that Order No. 20488, filed on October 27, 2003, should be vacated.


THE COMMISSION ORDERS that Order No. 20488 is vacated and this docket is closed.


