ORDER AMENDING DECISION AND ORDER NO. 20676

The commission recently approved SOUTH SHORE COMMUNITY SERVICES LLC's ("SSCS") request to transfer its utility operations, assets, and certificate of public convenience and necessity, to Kukui'Ula South Shore LLC, by Decision and Order No. 20676, filed on November 25, 2003. Subsequently, by letter dated December 1, 2003, SSCS informs the commission that the name of the new utility company is Kukui'Ula South Shore Community Services, LLC, and not Kukui'Ula South Shore LLC, as originally envisioned. SSCS explains that "[t]he change in the name is necessary because the Department of Commerce and Consumer Affairs would not permit registration of the name 'Kukui'Ula South Shore LLC.'"




Services, LLC. In all other respects, Decision and Order No. 20676 remains unchanged.
