ORDER

On October 8, 2003, LIMONIGHT, LLC ("Applicant") filed an application requesting a permit to operate as a contract carrier of passengers by motor vehicle over irregular routes on the islands of Maui and Kauai in the 8-to-25 passenger classification.


By a notice of dismissal dated December 3, 2003, we informed Applicant of our intent to dismiss the application without prejudice because of Applicant's failure to respond to the commission's request for information. Applicant was further advised that any objection to the dismissal of its application must be submitted in writing and filed not later than 10 days from the date of the notice, and that if an objection was not filed, the commission would issue an order dismissing the application.


Applicant did not object to the dismissal of its application within the 10-day period. We, thus, find that there is good cause to dismiss the application in this docket.


THE COMMISSION ORDERS that the application filed by Applicant on October 8, 2003, is dismissed without prejudice and this docket is closed.
