ORDER

On August 28, 2003, ISLAND BANANA COMPANY, INC., dba DAILY TRUCKING ("Transferor"), filed an application requesting commission approval to transfer certificate of public convenience and necessity number 18-C to PRO-SERVE HAWAII, INC. ("Transferee").


By a notice of dismissal dated January 23, 2004, we informed Transferor and Transferee of our intent to dismiss the application without prejudice because of Transferee's failure to respond to the commission's request for information. Transferor and Transferee were further advised that any objection to the dismissal of the application must be submitted in writing and filed not later than 10 days from the date of the notice, and that if an objection was not filed, the commission would issue an order dismissing the application.


Transferor and Transferee did not object to the dismissal of the application within the 10-day period. We, thus, find that there is good cause to dismiss the application in this docket.

THE COMMISSION ORDERS that the application filed by Transferor and Transferee on August 28, 2003, is dismissed without prejudice and this docket is closed.


