ORDER

On July 18, 2003, MORTON MASAO NII, dba EXTREME FUN HAWAII ("Applicant"), filed an application requesting a certificate of public convenience and necessity ("CPCN") to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 passenger classification. By Decision and Order No. 20619, filed on November 3, 2003, the commission granted Applicant a CPCN subject to certain requirements.

On April 1, 2004, Applicant filed a request to withdraw his application.¹ In light of this request, the commission finds good cause to void Decision and Order No. 20619, and to close this docket.


THE COMMISSION ORDERS:


1. Decision and Order No. 20619 is voided.
2. This docket is closed.


¹The commission will treat Applicant's request to withdraw the application as a request to void Decision and Order No. 20619.


