ORDER

I.

Conference: May 19, 2004

On May 19, 2004, a status conference was held at the commission's office, in accordance with Order No. 20946, filed on April 30, 2004. Chairman Carlito P. Caliboso presided. Counsel for Complainant APOLLO ENERGY CORPORATION ("Apollo") and Respondent Hawaii Electric Light Company, Inc. ("HELCO") (collectively, the "Parties") attended.

This order memorializes the results of the status conference, as follows:

1. By May 26, 2004, the Parties shall file with the commission their respective proposed final draft agreements, including Appendices.¹ The Parties have the option of filing a combined, single document, if feasible. The Parties shall also submit an electronic version of their documents to the

commission, in Microsoft Word format, at michael.a.azama@hawaii.gov, commission counsel's e-mail address.²

2. By May 26, 2004, the Parties shall file with the commission their respective proposed schedules for the completion of the preliminary and final Interconnection Requirements Study.

3. Following its receipt and review of the proposed final draft agreements, the commission will schedule another status conference. At this status conference, the commission may schedule the date for an evidentiary hearing or oral argument, if necessary. The Parties will be notified of the date and time of this status conference.³

4. At the conclusion of the May 19th status conference, Apollo's counsel submitted for the record a document entitled, "APOLLO's Comments on Compare/Merge Draft of 5/18/04, Status Conference Submission (05/19/04)." HELCO, in lieu of formally objecting to Apollo's document, will have the opportunity to file, by May 26, 2004, a response to Apollo's document.

Order


THE COMMISSION ORDERS that, unless ordered otherwise, the procedures noted in Section I, paragraphs 1 to 4, above, shall control this proceeding.




