ORDER

LOCKHEED MARTIN GLOBAL TELECOMMUNICATIONS SERVICES, INC. ("Petitioner") holds a certificate of authority ("COA") to operate as a reseller of intrastate telecommunications services.<sup>1</sup> The commission issued COA 01-0388 to Petitioner.

Petitioner requests the commission's approval to voluntarily surrender its COA.<sup>2</sup> Petitioner represents that: (1) it does not operate in the State of Hawaii (the "State"), and has no customers here; accordingly (2) "no customers will be adversely affected by these actions and there are no customers to be notified."

Given Petitioner's non-provision of telecommunications services in the State, the commission: (1) approves the voluntary surrender of Petitioner's COA, in lieu of revocation; and (2) waives the customer notification requirement set forth in

Hawaii Administrative Rules ("HAR") § 6-80-123(a), as Petitioner represents that it has no intrastate customers to notify of its discontinuance of telecommunications services.<sup>3</sup>

THE COMMISSION ORDERS:

1. Petitioner's request to surrender COA 01-0388 to operate as a reseller of intrastate telecommunications services is approved, effective from the date of this order. Petitioner shall promptly return COA 01-0388 to the commission.

2. The customer notification requirement set forth in HAR § 6-80-123(a) is waived.


3. This docket is closed.




