ORDER

By Order No. 20319, filed on July 11, 2003, certificate of public convenience and necessity no. 1261-C ("Certificate No. 1261-C"), held by FRANK J. LUCKETTI ("Petitioner"), was placed on inactive status until June 14, 2004.

Order No. 20319 informed Petitioner that if Certificate No. 1261-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to June 14, 2004, the commission would deem it to be abandoned and revoked.

June 14, 2004 has passed and Certificate No. 1261-C was not reactivated.<sup>1</sup> We, thus, find that there is good cause to revoke Certificate No. 1261-C.


<sup>1</sup>Petitioner filed documents with the commission on June 10, 2004, including, but not limited to, a Certificate of Liability Insurance, a Vehicle Inventory List, and a Certificate of Title. The documents were submitted in an effort to comply with the commission's requirements to reactivate Certificate No. 1261-C. The Certificate of Liability Insurance, however, indicated that Petitioner's automobile liability insurance coverage was below the minimum prescribed amount pursuant Hawaii Administrative Rules § 6-62-8, and, thus, Petitioner failed to comply with our requirements to reactivate Certificate No. 1261-C.


THE COMMISSION ORDERS that Certificate No. 1261-C is  
revoked, and this docket is closed.
