DECISION AND ORDER


The commission ordered KAUAI TRAILER RENTALS, LLC ("Respondent") to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 26, 2003 to show cause why Respondent's certificate of public convenience and necessity number ("No.") 3017-C should not be suspended or revoked for Respondent's failure to pay the interest and penalty amount of \$362.89, which the commission assessed pursuant to Hawaii Revised Statutes § 271-27(i) and Hawaii Administrative Rules §§ 6-62-24(b), 6-62-24(c), and 6-62-42(d) for Respondent's late payment of its annual motor carrier gross revenue fee and late filing of the 2002 annual financial report. On November 26, 2003, Respondent paid the assessed penalty and interest amounts.


The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 20487, filed on October 27, 2003, should be vacated.

THE COMMISSION ORDERS that Order No. 20487 is vacated and this docket is closed.


