ORDER

By Order No. 20599, filed on October 29, 2003, certificate of public convenience and necessity no. 1532-C ("Certificate No. 1532-C"), held by HAWAIIAN OUTDOOR ADVENTURE TOURS, INC., dba HAWAIIAN OUTDOOR ADVENTURES ("Petitioner"), was placed on inactive status until August 14, 2004.


Order No. 20599 informed Petitioner that if Certificate No. 1532-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to August 14, 2004, the commission would deem it to be abandoned and revoked.

August 14, 2004 has passed and Certificate No. 1532-C was not reactivated. We, thus, find that there is good cause to revoke Certificate No. 1532-C.


THE COMMISSION ORDERS that Certificate No. 1532-C is revoked, and this docket is closed.


