ORDER

I.

Introduction

On September 24, 2004, MAKENA WASTEWATER CORP. ("Applicant") submitted its revised tariff, which incorporates the amended tariff sheets and rate schedules, requested by the commission in Decision and Order No. 21352 ("Decision and Order No. 21352"), filed on September 16, 2004, in this docket.

2. This docket is closed.


