### ORDER AMENDING PREHEARING ORDER NO. 20923 and CLARIFYING ORDER NO. 21037

By this order, the commission modifies Prehearing Order No. 20923, filed on April 23, 2004 by amending the procedural schedule and deleting paragraph 2 of Attachment 1, page 16, Section VIII to be consistent with a modified hearing format, as further described herein. The commission also clarifies Order No. 21037 by requiring all Parties and Participants to provide an electronic copy of all past and future filings with the commission in Word 97, Word 2000, or Word 2003, the standard programming format for filings in this case.

I.

#### Introduction

On April 23, 2004, the commission issued Prehearing Order No. 20923, setting forth the regulatory schedule and procedures that govern this proceeding.<sup>1</sup>

On December 16, 2004<sup>2</sup>, the commission issued a letter, informing the Parties and Participants<sup>3</sup> that it intends to implement a hearing format that is substantially similar to the hearing format recently implemented at the hearings held on December 8-10, 2004 in Docket No. 03-0371 relating to Distributed Generation.<sup>4</sup> By that same letter, the commission also gave the Parties and Participants an opportunity to submit proposals, jointly or independently, to amend Prehearing Order No. 20923 for the commission's review and approval.

On January 5, 2005, The Parties and Participants' submitted their joint proposal to modify Prehearing Order No. 20923. In particular, they proposed to modify the regulatory schedule established in Prehearing Order No. 20923 and requested that the Commission submit its discovery at the same time discovery is submitted by the Parties and Participants.

Participants to file the Original plus ten (10) copies of documents filed with the commission and requiring the parties to provide an electronic copy of all past and future filings with the commission.

By Order No. 21540, filed on January 11, 2005, the commission suspended all filings in this docket, until further order by the commission. On January 13, 2005, upon reviewing the January 5, 2005 joint proposal, the commission sent a letter to the Parties and Participants proposing an alternative proposed schedule and requesting comments on the proposed dates and revisions to the issues by January 21, 2005.

On January 21, 2005, the Consumer Advocate filed proposed revisions to the commission's alternative proposed schedule, particularly the commission's proposed due dates for the procedural steps contemplated for this proceeding in order to accommodate the procedural schedules in other docketed matters. The Consumer Advocate represents that HECO, HELCO, MECO, KIUC, THE GAS COMPANY, and the COUNTY OF KAUAI agreed with the Consumer Advocate's proposed revisions. The Consumer Advocate represents that HAWAII RENEWABLE ENERGY ALLIANCE indicated that either the commission's schedule the Consumer Advocate's revisions are acceptable; the COUNTY OF MAUI and HESS MICROGEN have indicated that thev support the schedule, but commission's will support the proposed Consumer Advocate's revised schedule, if the other Parties agree.

II.

#### <u>Discussion</u>

Based on our review, we find the Consumer Advocate's January 21, 2005 proposed revisions to the regulatory schedule ("amended regulatory schedule") to be reasonable, and thus will

approve and adopt the amended regulatory schedule in its entirety. The amended regulatory schedule, attached hereto as Exhibit "A", will replace and supersede any prior regulatory schedule approved by the commission in this docket. Although the commission has scheduled its own issuance date of information requests to the Parties and Participants, the commission notes that it will continue, like any other investigatory proceedings before the commission, to conduct its investigation as it deems necessary to ensure that it has a complete record to render an informed decision in this docket. In this regard, the commission may need to take a more active role in the discovery process, which may include additional information requests to the Parties and Participants.

In addition, the commission also finds it necessary to further amend Prehearing Order No. 20923, Exhibit 1, to be consistent with the modified hearing format. Page 6, Section IV should be deleted. Page 15, Section VIII should be amended by deleting paragraph 2.

Further, by this Order, the commission clarifies Order No. 21037, filed on June 9, 2004, by requiring all Parties and Participants to provide an electronic copy of all past and future filings with the commission in Word 97, Word 2000, or Word 2003, the standard programming format for filings in this case. Like other filings, if workpapers, documentation, or exhibits attached to any filing are not readily available in an electronic format, a Party or Participant shall not be required to convert

such workpapers, documentation, or exhibits into an electronic format.

#### <u>Order</u>

#### THE COMMISSION ORDERS:

- 1. The Consumer Advocate's January 21, 2005 proposed revisions to the regulatory schedule attached hereto as Exhibit "A" is approved and shall be adopted in its entirety. Exhibit "A" shall replace and supersede any prior regulatory schedule approved by the commission in this docket.
- 2. Prehearing Order No. 20923 is amended consistent with the terms of this order. In all other respects, Prehearing Order No. 20923 remains unchanged.
- 3. Order No. 21037 is clarified to the extent provided in this Order.
