#### **ORDER**

By this Order, the commission orders that the application filed by ADCOM INC. ("Applicant") on November 19, 2004, is dismissed without prejudice and this docket is closed.

I.

#### Application for Common Carrier Authority

On November 19, 2004, Applicant filed an application requesting a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification.

By a Notice of Dismissal dated January 27, 2005, we informed Applicant of our intent to dismiss the application without prejudice because of Applicant's failure to respond to the commission's request for information. Applicant was further advised that any objection to the dismissal of its application must be submitted in writing and filed not later than 10 days from the

date of the notice, and that if an objection was not filed, the commission would issue an order dismissing the application.

II.

### Findings and Conclusions

Applicant did not object to the dismissal of its application within the 10-day period. We, thus, find that there is good cause to dismiss the application in this docket.

#### Order

THE COMMISSION ORDERS that the application filed by Applicant on November 19, 2004, is dismissed without prejudice and this docket is closed.
